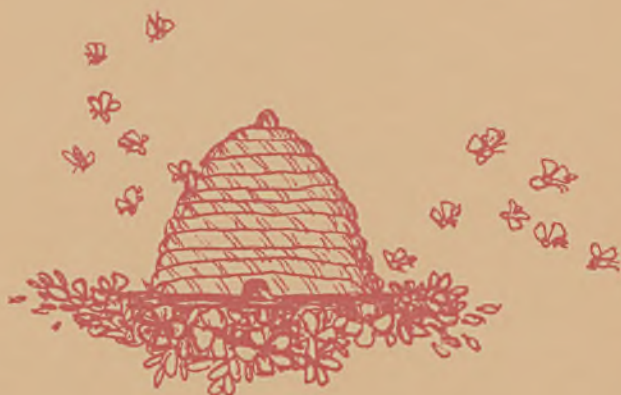

About the Meeting

The 1991 OHA conference features a total of fifty-four sessions in three categories: practical workshops, concurrent sessions/panels, and plenary sessions. Workshops and concurrent sessions are located on Levels B and C at Snowbird, with all plenary sessions held in the Ballroom on Level B.

Workshop Fees. OHA is again offering workshop sessions taught by experienced faculty to provide hands-on training for oral historians. Both introductory and advanced workshop sessions dot this year's program, starting with three Family History Workshop sessions on Thursday and ending with a daylong workshop for teachers on Saturday. Sessions on revised legal concepts, radio production, community history, and basic interviewing techniques are also offered.

Preregistration is required for all these workshops, and the family, radio, and teachers' workshops also require special fees to defray cost of equipment and related materials. Enrollments may be limited, so interested participants should reserve places for themselves through early conference registration.

Exhibit Room. The Maybird Room will feature exhibits by publishers, oral history centers, manufacturers, and regional/local oral history organizations. It is located on Level C very near many of the session rooms and break areas. Conference participants are encouraged to visit the exhibits to meet authors and publishers of recent publications and to browse the exhibits. The Exhibit Room will close at noon on Saturday.

Summation/Evaluation Session. The conference will again close with a collective summation led by Past President Martha Ross of Bethesda, Maryland. Participation by all attending is encouraged, for such discussions assist the planners of future OHA annual meetings. The Summation/Evaluation Session will take place immediately following the annual business meeting, on Sunday morning in the Ballroom, on Level B.

Featured Speakers

Clyde Benally is a member of the Navajo nation and lives in Cortez, Colorado, where he is employed by Mobil Oil. He grew up in a Navajo-speaking family and has drawn from his own experience to work for the integration of Native American oral traditions into the school curriculum.

Vicki L. Ruiz is Associate Professor of History at the University of California, Davis. A longtime oral historian, her publications include *Cannery Women*, *Cannery Lives: Mexican Women, Unionization and the California Food Processing Industry, 1930-1950*, and most recently, with Ellen Carol DuBois, *Unequal Sisters: A Multicultural Reader in U.S. Women's History*.

The Deseret String Band is comprised of Hal Cannon, who during the day is director of the Western Folklife Center and researcher and author of folk art topics in the West; Tom Carter, a folklorist and architectural historian on the faculty at the University of Utah; Leonard Coulson, who makes banjos and owns a guitar and banjo shop specializing in vintage instrument repair and sales; and Ron Kane, who is an avalanche expert at Alta Ski Resort.

Rod McQuery, cowboy poet, lives in Ruby Valley, Nevada, where he ranches, guides, and packs into the Ruby Mountains, and shoes horses part-time. The subjects in his poetry include his neighbors, his work, and the changing times in the valley.

Irina Lazarevna Sherbakova was educated at Moscow State University, receiving a degree in German literature and history in 1971. She has been involved with oral history since 1979, and her primary research has concentrated on women's experiences in the Soviet gulag, or correctional labor camps. She is affiliated with the Institute for Oral History in Moscow and serves as correspondent in literature for a Soviet newspaper.



Snowbird/Travel Information

Hotel Accommodations

Cliff Lodge, the newest and most spacious unit in the Snowbird Ski and Summer Resort, is the site of the OHA meeting. The Snowbird Conference Center is on several levels of Cliff Lodge, which also houses the guest rooms we will occupy. Suites and dormitory accommodations are available as well as single- and double-occupancy rooms--all with scenic views of the Wasatch Range. Call for information about available condominiums.

Only a few yards away a tramway runs daily to the summit of Hidden Peak (11,000 feet) which offers the most spectacular vista of the region. Unobstructed views of the mountains are possible from vantage points ranging from conference rooms to most guest quarters' bathrooms. In the lodge are a heated pool, sauna, exercise room, whirlpool, and related services. Recreational opportunities include hiking, tennis, volleyball, and professionally organized activities. Restaurants, shops, and galleries are located throughout the complex.

Environment/Climate

Snowbird is located at 8,000 feet in altitude southeast of Salt Lake City in the Wasatch Range and national forest. The conference center, which is both a ski and summer resort, is in the scenic Little Cottonwood Canyon on Utah State Road 210, and is only a few miles from the former silver boomtown of Alta. An alpine climate of cold nights and cool-to-mild days may be expected, and visitors should **bring warm clothing and comfortable walking shoes**. Allowances for the altitude are encouraged as visitors move about the grounds and mountain slopes. Expect the climate to be a bit warmer and drier in Salt Lake City itself.

Travel Tips

By car: For those who wish to drive, Snowbird Conference Center/Ski and Summer Resort is located on a mountain road (Utah State Road 210) southeast of the junction in Salt Lake City of Interstate 80 and Interstate 15, principal highways in the region.

By rail: Amtrak serves Salt Lake City with both east-west and north-south routes. Amtrak uses the Rio Grande Railway Station, which is also the home of the Utah State Historical Society. For information on transportation from the rail station to Snowbird which avoids high taxi fares, call (in advance) Canyon Transportation, in Sandy, Utah, at 801/255-1841.

By air: The Salt Lake City airport is a hub for Delta, OHA's official airline. For discounted air fares, call Delta at 800/241-6760 Mon.-Fri. 7:30 a.m.-11 p.m. EDT and Sat-Sun., 8:30 a.m.-11 p.m. EDT, and ask for Reference Number E0628.

Canyon Transportation--801/255-1841--will provide transportation from the Salt Lake City airport to the Snowbird Cliff Lodge and return. The rate on shared passage is \$14 per person one-way. Any single individual transportation is \$56 one-way. Conference attenders are encouraged to combine transportation schedules to and from the conference.

Upon registering for the conference, please include in the information sent to the association secretary the flight numbers, times of arrival and departure, and dates of travel. The Local Arrangements Committee will be on hand at the airport and hotel to assist in grouping transportation to and from the airport. Call ahead to Canyon Transportation to make reservations.

Arrival by air: The Canyon Transportation Company will staff two counters in terminals A and B within the Salt Lake City airport complex. Attenders should come to these locations after retrieving their luggage. Transit time one-way is approximately 45-60 minutes.

Departure by air: Canyon Transportation will be available for departures from Snowbird to the airport on Sunday beginning at 7:00 a.m. Attenders are encouraged to schedule departure times with them as soon as possible.

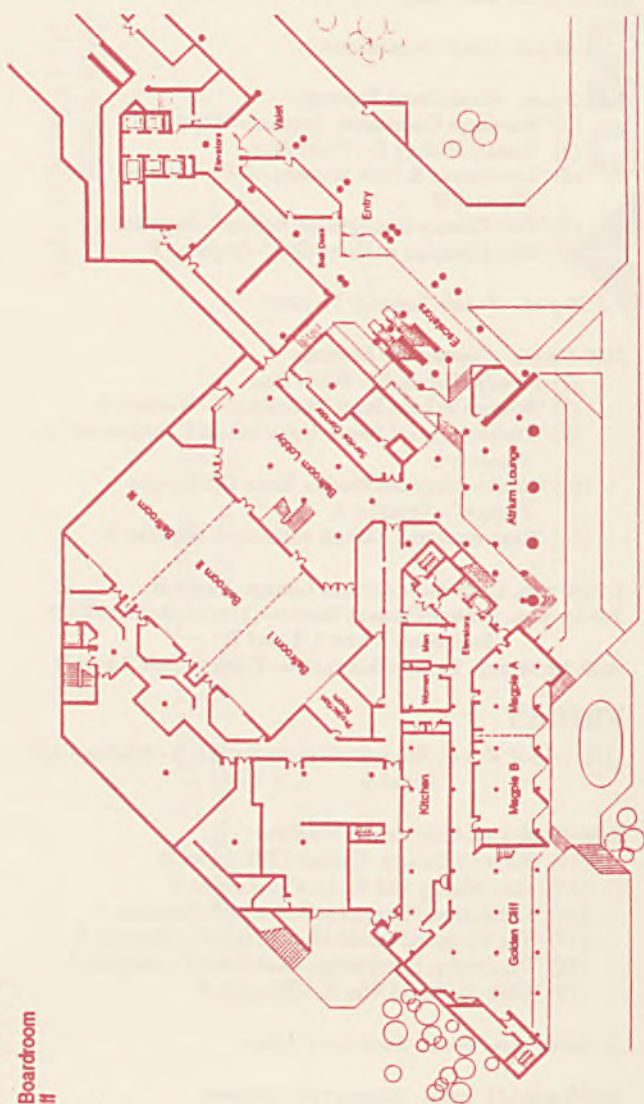

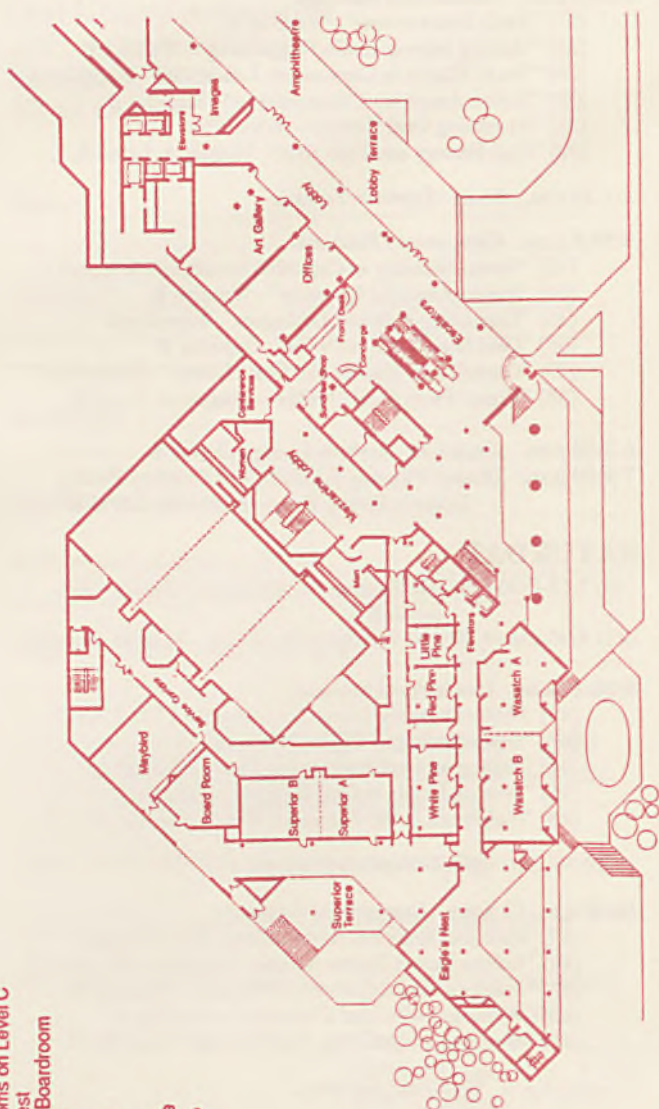
